SBS joined Ararat Skilled Nusing Facility as Inspector of Record in 2011, alongside Jeff Sobin and Bob Simonian of Sobin Harte Architects. Ararat is a 254-bed, multiple award-winning skilled nursing facility offering short-term rehabilitation and long-term care. We are proud to have participated in the expansion project, which consisted of two phases. Phase 1 included the relocation and replacement of the existing emergency power generator set and all associated conduit, feeders, automatic transfer switch distribution panels, CMU enclosure, footings and anchorage as required. Phase 2 involved construction of a 19,000 square feet two-story Type IIA load bearing light gauge metal framed walls with X-strap braced shear wall and metal deck with light-weight concrete

floor and roof over metal joist. This phase also included 66 skilled nursing beds, dining and recreating facilities, nursing stations and related support spaces. Today, we avidly continue our partnership with Ararat and Sobin Harte, currently working on the Physical Therapy Remodel and the Storage Water Tank project in plan review. We look forward to joining this incredible team on future projects too.
