With multiple paralleled generators, verifying the load shed and load demand sequence by priority is a necessary function to be performed with the IOR and OSHPD AHJ. First priority loads can be grouped with the life safety and critical branch or separated based on the design or capacity of the generators. Loss or failure of a generator will shed the lowest priority starting with optional loads or the equipment branch. Restoring operation to the failed generator will see additional load available and will allow the equipment branch and optional loads to automatically come back on line. Performing this test ensures the design requirements are met and the sequencing is correctly programmed.
